Terms and Conditions

Driver Requirements

- All drivers must present a valid government-issued driver's license.
- Ocean Breeze Beach Resort will retain a copy of each driver's license.
- Only drivers listed on this agreement may operate the golf cart.
- Minimum driver age: **18 years**.

Use by an unauthorized driver immediately transfers full financial liability to the renter. The renter/cardholder remains fully financially responsible for the golf cart regardless of who operates it.

Security Deposit Authorization

A refundable security deposit of **\$500 USD** is required prior to release of the golf cart. The renter authorizes Ocean Breeze Beach Resort to apply the deposit toward:

- Damage
- Cleaning
- Fuel
- Missing equipment
- Violations of agreement
- Administrative costs
- Additional rental time

The security deposit is not an insurance policy and does not limit the renter's liability.

Golf Cart Condition & Fuel

The golf cart is provided with a full fuel tank, key, and security cable lock. The renter agrees to return the golf cart:

- With a full fuel tank
- With all equipment provided
- In the same operating condition

Charges:

- Missing key: \$20 USD
- Missing lock: \$20 USD
- Other items: replacement cost
- Fuel refill: market rate + service handling

The renter confirms the golf cart was inspected and accepted in good operating condition at the time of rental.

Permitted Area of Operation

Operation is limited to the Placencia Peninsula only. The northern boundary is Umaya Resort. Strictly prohibited:

- Sidewalks
- Beaches
- Off-road terrain
- Water crossings
- Commercial hauling

Violation results in **\$250 USD operational misuse charge per occurrence** and full damage responsibility.

Passenger Limit

Maximum occupancy: **4 people**. Overloading transfers full liability to renter and incurs a \$250 USD misuse charge.

Accidents & Damage Responsibility

The renter is responsible for the first \$500 USD of damage and any repair or replacement cost exceeding the deposit amount. In the event of an accident, the renter must:

1. Contact Ocean Breeze Beach Resort immediately
2. Contact the police immediately
3. Not move golf cart unless required for safety

Failure to report an accident immediately transfers full responsibility for all damages to the renter. Mechanical inspections and repair estimates from a licensed mechanic constitute acceptable proof of damage cost.

Prohibited Operation

Golf cart may not be operated:

- Under the influence of alcohol or drugs
- By unauthorized drivers
- Outside permitted area
- For illegal activity
- Without locking when unattended
- After mechanical warning signs
- After running out of oil/water, causing damage

Misuse voids all protections under this agreement, and the renter assumes full financial responsibility.

Rental Period & Automatic Extension Charges

The rental period begins and ends at the agreed time listed on this agreement. If the golf cart is not returned on time, the renter **authorizes automatic extension of the rental**:

- Up to 2 hours late: \$15 USD per hour
- More than 2 hours late: full additional rental day
- If another guest reservation is affected: \$65 USD service recovery fee

These charges are agreed rental extensions and operational recovery costs and are not penalties. The renter authorizes charges to the payment method on file without further notice. Billing continues until golf cart is returned. Continued possession of the golf cart constitutes acceptance of additional rental charges.

Personal Injury & Liability Waiver

The renter understands golf cart operation involves inherent risks. The renter assumes full responsibility for:

- Passengers
- Third parties
- Property damage
- Medical costs

Ocean Breeze Beach Resort, its owners and employees are not liable for injury, death, or damages arising from use of the golf cart.

Ocean Breeze Beach Resort is not responsible for loss or damage to personal belongings left in or on the golf cart.

Payment Authorization & Charge Agreement

By signing, the renter authorizes Ocean Breeze Beach Resort to charge the payment method provided for:

- Missing equipment
- Violations
- Additional rental time
- Administrative costs

The renter agrees to contact the resort directly to resolve disputes prior to initiating a credit card chargeback. Photographs, video, and repair estimates may be used as documentation supporting charges.
